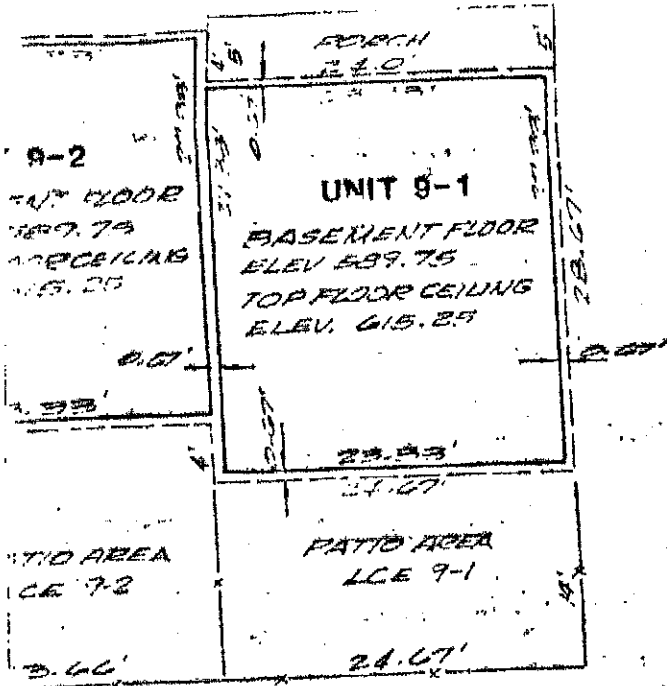
BUILDING 9

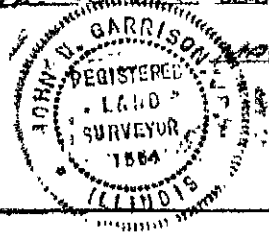
BUILDING 6
